Genocide is defined as *the intent to exterminate, in whole or in part, a national, ethnic, racial, or religious group.*

Children are overlooked in the casualties of genocide. They are victims of violence and displacement. They become orphans and witnesses to terrible atrocities. Children are used as soldiers and as supporters for militias and armies. Their futures are forever changed.

Explore the many faces of children during the Holocaust, the genocides in Rwanda, Guatemala, and of the Native Americans, and current crises in Sudan.

The Institute welcomes high school and college students. Students will spend three days, 10:00 am - 9:00 pm, participating in a variety of activities including a mock trial, learning from experts and survivors, participating in a simulation, and building skills to become human rights leaders.



Learn from local activists and experts in the field, discussions with survivors, and activities.

Serve together during the school year to build a home with Habitat for Humanity.

Advocate for local, state, and national policies.

Lead as an 'upstander' and become part of the next generation of human rights leaders.

Student Requirements:

- Be enrolled in high school or college by September 2017.
- Commit to attend all sessions, 10:00 am - 9:00 pm.
- **NEW STUDENTS:** Submit a 250-word statement telling us why you want to participate in the Institute.
- **RETURNING STUDENTS:** Submit a 250-word statement sharing what you gained from last summer's Institute and why you wish to return this year.
