Genocide is defined as *the intent to exterminate, in whole or in part, a national, ethnic, racial, or religious group*.

The Nazi extermination of Jews was not the first time a religious group has been singled out for violence. Before the Jews it was Christian Armenians who lived in a largely Muslim country. Recently there has been violence between Christians and Muslims in several countries in Africa; against Muslims and Christians by Buddhists in Burma; and sectarian violence by terrorist organizations such as ISIS in the Middle East.

Explore why religious groups are targeted, how to prevent this conflict, and how to advocate for laws and policies to prosecute perpetrators.

The Institute welcomes high school and college students. Students will spend three days participating in critical thinking and reflection activities, learning from experts and survivors, and building the skills to become leaders in human rights advocacy.



Learn: engage in presentations from local activists and experts in the field, discussions with survivors, and activities such as musical and theatrical performances, reflection exercises, and group discussions.

Serve: come together during the school year to build a home with Habitat for Humanity.

Advocate: gain the knowledge and skills to become an 'upstander' and support policies at local, state, and national levels.

Lead: build the strength, commitment, and compassion to become the next generation of human rights leaders – today.

Student Requirements:

- Be enrolled in high school or college by Sept. 2015.
- Commit to attend all sessions, 10 am 9 pm.
- **NEW STUDENTS**: Submit a statement telling us why you want to participate in the Institute.
- RETURNING STUDENTS: Submit a statement sharing with us what you gained from last summer's Institute and why you wish to return this year.

The Institute may be used for service hour credits.
